

Terms and Conditions:

This campaign is jointly offered by Qatar Airways Group Q.C.S.C. acting through its Privilege Club loyalty programme (“**Qatar Airways**”) and Doha Bank Q.P.S.C. (“**Doha Bank**”) (together, the “**Promoters**”).

Doha Bank Shall be responsible for determining eligible transactions and qualifying spend under this campaign and Qatar Airways is responsible for awarding Avios to eligible members.

This offer is valid from **1st July 2026 to 15th August 2026** (inclusive) (the “Campaign Period”). Transactions posted after the Campaign Period will not be eligible for this offer.

- **Eligibility:** The campaign is open to all Qatar Airways Privilege Club Infinite and Signature credit cardholders issued by Doha Bank, whose accounts are active and in good standing.
- **Earning Avios:** Tiered Avios bonuses based on international spending thresholds.

Qatar Airways Visa Infinite Card:

- Cardholders will earn 10,000 bonus Avios for International spends equivalent to the value of QAR 10,000 (**Minimum**).
- Cardholders will earn 20,000 bonus Avios for International spends equivalent to the value of QAR 20,000.
- Cardholders will earn 30,000 bonus Avios for International spends equivalent to the value of QAR 30,000 (**Maximum**).

Qatar Airways Visa Signature Card:

- **Avios Crediting:** Bonus Avios will be credited to eligible members' Qatar Airways Privilege Club accounts within 60 days after the end of the Campaign Period, subject to data reconciliation between partners and provided the credit card account is active and in good standing at the time of crediting. Qatar Airways and Doha Bank will not be responsible for any delay or failure in crediting Avios due to circumstances beyond their reasonable control.
- "International Spend" means eligible transactions made in a currency other than QAR and processed as cross-border transactions using the Doha Bank Qatar Airways Co-Brand Credit Card, as determined by Doha Bank based on its transaction records.
- **The following transactions will not qualify for Avios:** cash withdrawals, balance transfers, fees, charges, and any transactions which are cancelled, refunded, reversed or disputed. Doha Bank reserves the right to exclude any transaction which it reasonably determines is not a genuine retail transaction or is otherwise outside the intended scope of this campaign.
- **Eligible Transactions:** International Spend transactions will qualify for the bonus Avios during the specified Campaign Period. "International Spend" means eligible transactions made in a currency other than QAR and processed as a cross border transaction using your Qatar Airways Co-Brand Credit Card by Doha Bank, as determined by the Bank in its sole discretion, based on its records.
- International transactions completed via Qatar Airways Privilege Club Credit Card by Doha Bank including any security deposits, refunded/cancelled/reversed due to any reason will be subject to the general refund policy for Doha Bank/Qatar Airways Co-brand cards where applicable.
- **Exclusion**
 - The customer should not be a delinquent customer for any facilities obtained from Doha Bank. KYC should be up to date.
 - Customer should not be in the blacklisted database subject to AML/CFT/Sanctions/Regulatory breaches or in the blacklist of the bank and/or not have any criminal offence as per the Laws of Qatar.
 - Domestic spends Ecommerce or POS are excluded from the campaign.
- **Changes and Termination:** The Promoters reserve the right to amend, suspend or terminate this campaign at any time, to the extent permitted by applicable law.
